


## Our Recommendations

The table lists all the wards we are proposing as part of our final recommendations along with the number of electors in each ward. The table also shows the electoral variances for each of the proposed wards which tells you how we have delivered electoral equality. Finally, the table includes electorate projections for 2027 so you can see the impact of the recommendations for the future.

## Final Recommendations on the new electoral arrangements



### Who we are

- The Local Government Boundary Commission for England is an independent body set up by Parliament.
- We are not part of government or any political party.
- We are accountable to Parliament through a committee of MPs chaired by the Speaker of the House of Commons.
- Our main role is to carry out electoral reviews of local authorities throughout England.

### Electoral review

An electoral review examines and proposes new electoral arrangements for a local authority, including:

- The total number of councillors representing the council's electors ('council size').
- The names, number and boundaries of wards or electoral divisions.
- The number of councillors for each ward or division.

### Why Guildford?

- The Commission has a legal duty to carry out an electoral review of each council in England 'from time to time'.
- Guildford Borough Council has not been reviewed since 1998 and the Commission has therefore decided that it should review Guildford in advance of the elections in 2023.

### Our proposals

- Guildford Borough Council currently has 48 councillors. Based on the evidence we received, we recommend that 48 councillors should serve the council in the future.
- We believe our final recommendations meet our statutory criteria to:
  1. Deliver electoral equality for electors
  2. Reflect community interests and identities
  3. Promote effective and convenient local government

## Summary of our recommendations

We have considered all the submissions we received during our consultation on our draft recommendations.

Our final recommendations propose that Guildford Borough Council should have 48 councillors, the same as at present.

Those councillors should represent 21 wards, representing eight three-councillor wards, 11 two-councillor wards and two one-councillor wards.

The boundaries of most wards should change; four will stay the same.


Stage of Review	Description
26 January 2021 - 2 August 2021	Public consultation on warding arrangements
30 November 2021 - 7 February 2022	Public consultation on draft recommendations
10 May 2022	Publication of final recommendations
May 2023	Subject to parliamentary approval - implementation of new arrangements at local elections
