# General Proposals

In completing this analysis, the Conservative Group have worked with the 2029 electorate forecast. We have used the average ward size under this forecast of 14,930 as being the baseline for ward size and have tried where possible and appropriate to keep within a 5% variance from this figure.

Those wards which are within tolerance we have tried to keep unaltered, if possible, although this has not always been possible due to the knock-on effect of neighbouring wards.

We have tried where possible to keep communities intact, and to re-unite communities that were divided in the last boundary review. Examples are the inclusion of all Birstall into the Birstall & Birkenshaw Ward, which before had one quarter of the town in Batley West Ward; the inclusion of parts of Gomersal into the Liversedge & Gomersal Ward from the Birstall & Birkenshaw Ward; and the inclusion of parts of Heckmondwike which were in the Liversedge & Gomersal Ward into the Heckmondwike Ward.

This makes the boundary lines of some wards less identifiable, but we argue that it is more important that electors realise which ward they are in, rather than having neat boundary lines which run up roads or along rivers.

We have also tried to formulate wards which contain similar communities or communities with links.

Where possible, our aim is to keep wards co-terminus with existing Parish and Town Councils. This is achievable with Denby Dale Ward, and we are proposing an exemption for Mirfield Ward which will be slightly over tolerance but co-terminous with the Town Council (this argument was accepted in the 2003 review). Kirkburton Parish, which is currently split across three wards, we are proposing to split across two wards. Holme Valley Parish Council is split as now across two wards and Meltham Town Council is wholly retained within the Holme Valley North Ward.

A corollary of keeping Mirfield Ward so-terminus with the Town Council is that three other North Kirklees wards become slightly under the -5% tolerance but we feel this is a price worth paying for keeping communities together.

We propose that, in keeping with the towns of Dewsbury and Batley, some Huddersfield wards are renamed as Huddersfield North, Huddersfield South, Huddersfield East, Huddersfield West and Huddersfield Central. We feel this is preferable to using the names of one or two smaller communities within a ward which comprises several such communities and is more easily understood.

We would invite the Commission to support our proposals, and where necessary realign polling district boundaries slightly in order to, for example, make a better split between Batley East and Batley West.

# Individual Ward Proposals

Below is a ward-by ward analysis breaking down any polling districts which we propose to be added to or removed from particular wards.

In a few cases we feel that the most sensible proposal is to split a polling district. These are also detailed below along with the justifications as to why we believe these are the most sensible proposals for each ward looking ahead to 2029.

Where changes to wards have been proposed a map of the new area has been included. **Orange** are those districts remaining in the ward, **Red** are those districts being removed from the ward and **Green** are those districts being added to the ward.


## Justifications

The DA06 polling district is the village of Kirkheaton, which is part of Kirkburton Parish Council. By transferring this polling district to the Almondbury Ward we can split Kirkburton Parish area over two rather than three wards.

The rural village of Kirkheaton fits better with the similar neighbouring villages of Almondbury and Lepton rather than the urban area which makes up most of the Dalton Ward and have good transport connections.

We propose that the ward name be retained as Almondbury Ward.




## Justifications


The addition of the majority of BW02 re-unites the town of Birstall wholly within the ward, instead of this part of the town being in Batley West Ward, thus keeping a community together.

There is a small transfer from BB04 into Batley West Ward which aligns the boundary between Birstall & Birkenshaw Ward and Batley West Ward along Huddersfield Road and Bradford Road. This we feel gives a better boundary.

We propose the name Birstall & Birkenshaw Ward is retained.






## Justifications

It is worth noting that there are plans for thousands more dwellings in the ward at Chidswell under the Kirklees Local Plan, so slightly under tolerance we would suggest is acceptable in this case.




## Justifications




## Justifications

Holme Valley South (HVS) was oversized, and Holme Valley North (HVN) was slightly undersized based on the 2029 forecast. In order to preserve the Holme Valley, split between the two wards, the only polling district which could realistically be moved from HVS to HVN is district HS05. However, this district has a high population and moving it in its entirety simply reverses the problem, making HVN too big.

We believe that a split of HS05 is therefore required. The most natural split of this district runs along Moor Lane and Thong Lane. Our proposal is that anything north on and above these streets is allocated to HVN. This appears to cover around 30% of the population of HS05 based on the last electoral role.

We propose no change to the name of the ward.


## Justifications






## Justifications


